ADP is a cloud-native enterprise data platform, seamlessly integrated with ADS, that empowers clients with immediate access to the data they need to support their investment process, while radically simplifying data management operations.

ADP provides an investment management data model covering public and private market front, middle and back-office data. Enterprise data mastering and gold copy creation incorporates AI/ML for detecting data anomalies. Data warehousing leveraging the Snowflake Data Cloud provides highly scalable as-of/as-at capabilities. Process orchestration and governance enable event-based automation and data visibility. The State Street Alpha portal provides a persona-driven user interface and self-service business intelligence tools. Flexible information delivery options include Snowflake data share, Parquet extracts and an API framework. ADP supports integration of third-party solutions, business applications and data and 24/7 outsourced data services provided by our global team helps clients with sourcing, mastering, validating, enriching and delivering their data.

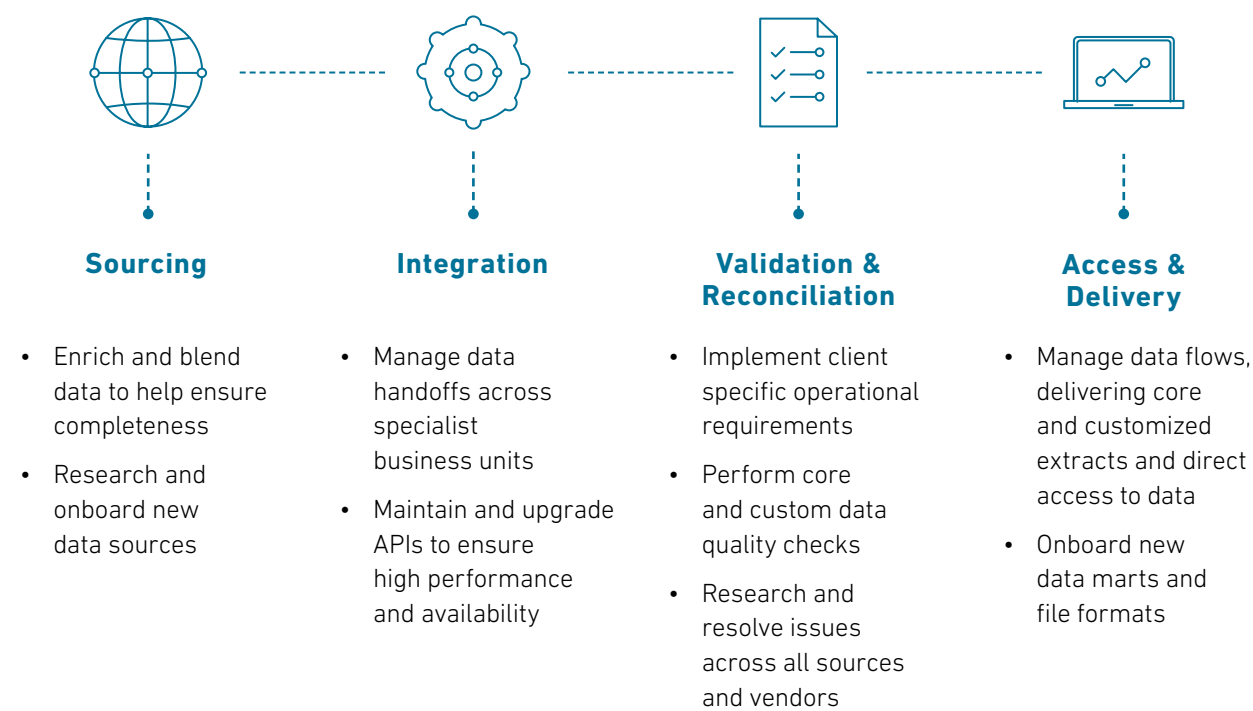

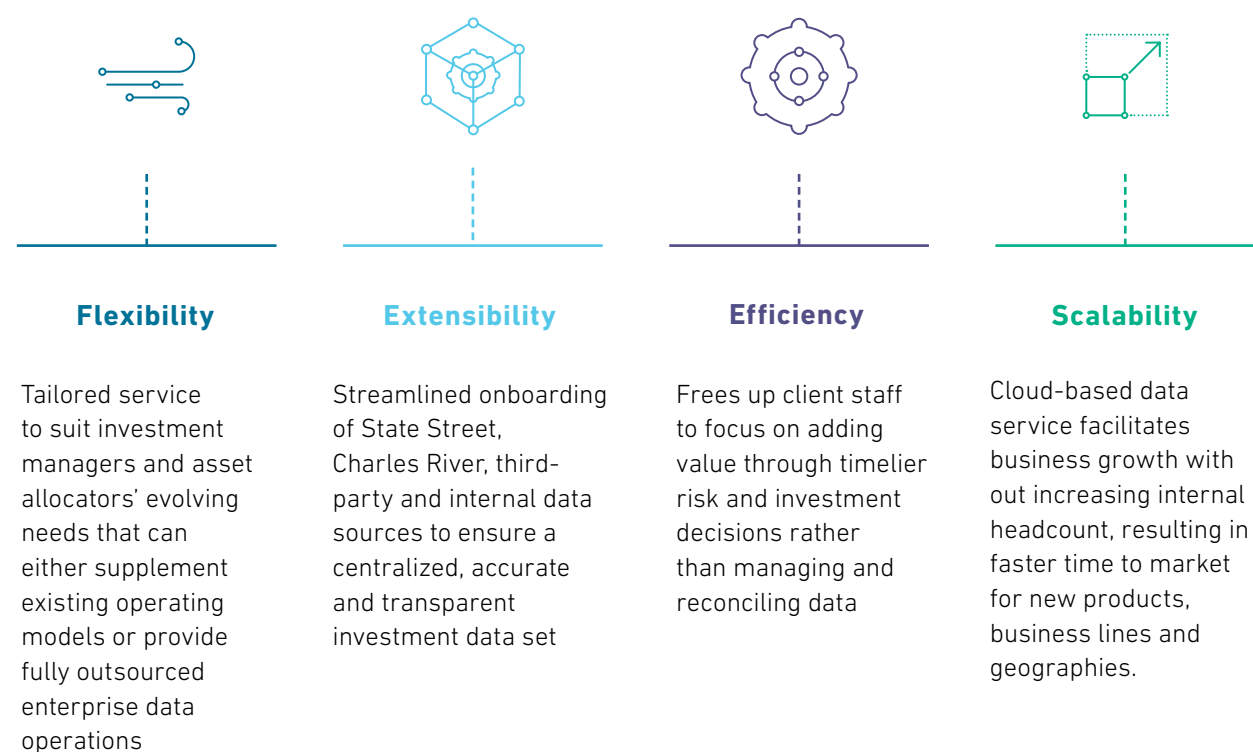

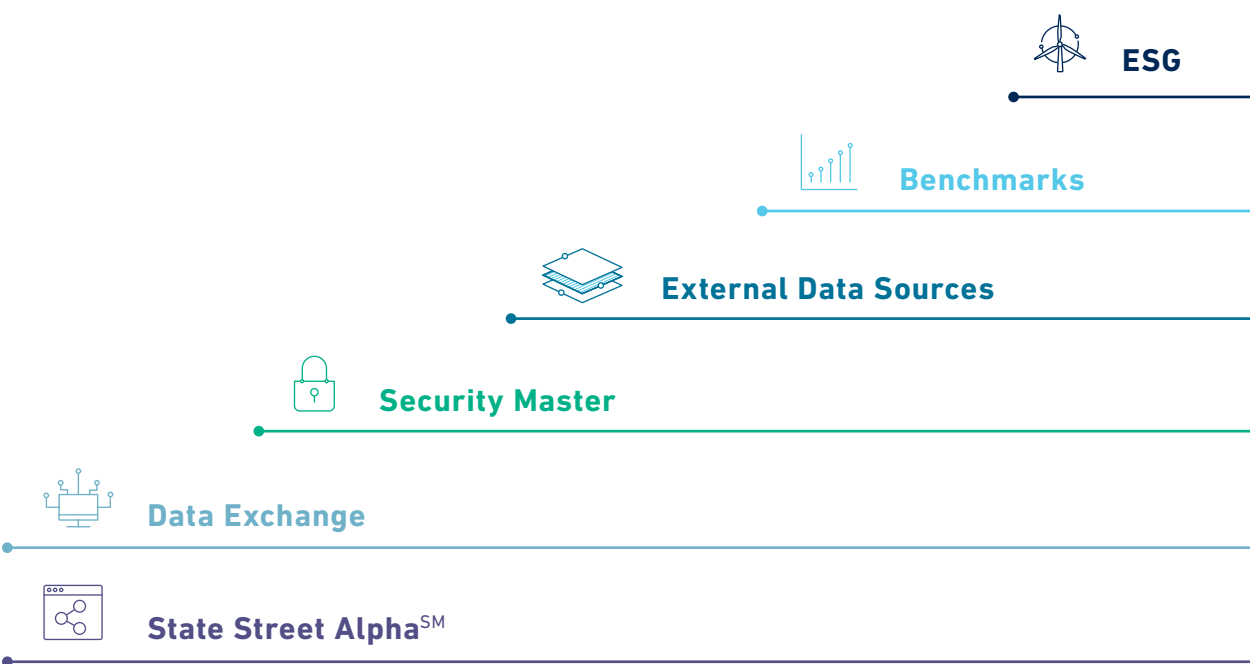

 - Execute validation checks to confirm file integrity and reconciliation are in scope
 - Provide standardization of reference code values across platforms
 - Normalize and enrich data to identify issuers, and identify relationships between LEI, issuer, and various other levels of the issuer hierarchy, down to the instrument level
